Perry Flynn, M.Ed. CCC/SLP is an AP Professor and the Consultant to the North Carolina Department of Public Instruction in the area of Speech Language Pathology. He is the Vice President for Planning and a Fellow of the American Speech-Language-Hearing Association. He has served as a member of ASHA's Board of Directors (2013-2015) as the Chair of the Speech-Language Pathology Advisory Council. Perry has served two terms on the Board of Directors of the North Carolina Speech Hearing Language Association in addition to serving on many of the association's committees. He has chaired ASHA's School Finance Committee, and has been a member of the School Service Delivery Committee, Convention Committee and Child Language Specialty Certification Task Force Practice Analysis Committee. He has served two terms as President of the State Education Agencies Disabilities Council.

Perry is co-author of ASHA publications: Developing Educationally Relevant IEPs and Conducting Educationally Relevant Evaluations and has presented many ASHA "webinars" on topics related to Federal and State Law and school service delivery. He has authored book chapters in Common Core State Standards and the Speech-Language Pathologist, (2015, Power-deFur), and Professional Issues in Speech-Language Pathology and Audiology, (2013, Lubinski and Hudson), and is a frequent contributor to the ASHA Leader and Perspectives publications.

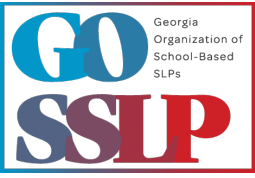
